

Office Order

Mr. Mohammad Ullah (ID-207), son of Wazi Ullah & Mahfuza Begum has been serving at Board of Intermediate and Secondary Education, Dhaka, Bangladesh as 'Assistant Controller of Examinations'. He is granted earned leave on full average pay (Ex-Bangladesh leave) for the purpose of performing Umrah in Saudi Arabia for 16 (Sixteen) days from 12th December, 2023 to 28th December, 2023 or from the date of departure under the following terms and conditions :

- (1) a. The employee will not be allowed to stay abroad more than the approved period ;
 - b. The employee will inform the authority after his return ;
 - c. The employee will draw his pay and allowances in local currency. No part of it should be drawn in foreign currency ;
 - d. All related expenses of the travel will be borne by himself ;
 - e. Travelling expenses will have to be shown in the income tax return and
 - f. The Provision of Rule 34 of Appendix VIII of BSR (Part-1) is applicable in this regard. That is to say, the employee has to start his leave within the 35 (thirty five) days from the date of this order as this order will not remain in force after the 35 (thirty five) days from the date of issue.
- (2) The above order has got the approval from the competent authority.
